2. The instructions regarding conduct of Computer Skill Test for the post of UDC will be uploaded on ESIC website separately.
3. Since the applications for the above post were called online only and hard copy of application along with documents in support of their eligibility for the post was not called from the candidates, **the candidature of all the candidates short listed for Computer Skill Test is purely provisional subject of fulfilment of eligibility criteria with regard to age, essential qualification, experience and reservation etc.**
4. Candidates short listed for Computer Skill Test must ensure that they belong the respective category/sub category as mentioned in the result above.
5. **The candidates must bring the Print Copy of Online Application/Admit Card at the time of Computer Skill Test along with one set of photocopy of requisite documents/certificate in support of their eligibility for the above post such as documents in support of Date of Birth, Educational qualification, Category (SC/ST/OBC), Sub Category (Ex-Serviceman), any other sub category under which relaxation in Age is sought (viz. J&K domiciled) etc.**
6. **Those candidates who are in Govt. Service (including ESIC Employees) are required to produce No Object Certificate (NOC) at the time of Computer Skill Test.**

7. Candidates belonging to OBC Category are required to submit latest OBC certificate in the prescribed proforma of Govt. of India appended below at Annexure – A along with Form of Declaration appended at Annexure – B below at the time of Computer Skill Test.

8. Candidates seeking age relaxation as Government Employee/ESIC Employee shall have to produce Service Certificate with Nature of Duties at the time of Computer Skill Test. Similarly, candidates who are Ex-serviceman and also at present in Govt Service should produce Service Certificate from present employer at the time of Computer Skill Test clearly mentioned their status of service viz. Regular/ Contractual/ Casual/ Temporary (Adhoc).
